PURPOSE OF THE POSITION

This position requires the project management of infrastructure facilities to ensure the completion of projects within budget, timeframe and to expectations of Council's water, sewer and storm water infrastructure. This position requires providing necessary guidance and input for the design of water and sewer infrastructure, manage the process of design procurement including engagement of contractors or service providers and review and amend design as necessary. This position is also responsible for facilitating the implementation of development assessment systems and processes and the processing of development applications and determination of engineering development within the Council.

KEY ACCOUNTABILITIES

- Manage and complete assigned minor and major capital projects within budget and delivery timeframes. Ensure all documentation relating to projects is completed and works as executed information updated on asset management systems.
- Monitor and manage the performance of contractors such as conducting site meetings and investigations and provide regular updates to supervisor on a weekly / monthly basis.
- Manage the review of project scopes, policies, procedures and investigations that are related to water and sewerage infrastructure.
- Provide technical guidance and input in design of water and sewerage infrastructure, manage the design review process and manage the engagement of contractors for design procurement of water and sewerage infrastructure.
- Provide problem solving skills and technical input to the investigation and design functions within water and sewer operations (e.g. practices and staff development).
- Contribute to the development and improvement of WH&S and risk management practices within water and sewer operations. Ensure all contractor management plans are developed, assessed and adhered to at all time.
- Lead and participate with project teams in the delivery of water and sewerage operation activities and minor and major capital projects.
- Management and preparation of contract documentation (i.e. tender processes) and technical specifications relating to operational and minor capital projects.
- Manage business risk by providing regular updates and communication for both operational and capital projects that impact any related areas within Council and the community.
- Liaise with the Sustainable Growth department in relation to development and subdivision applications for uniform and consistent outcomes.
- Assess development applications and provide conditions of consent related to water, sewer, storm water and trade waste after applying relevant legislations, specifications and standards.

- Respond to internal and external customer enquiries (front counter, telephone and written) relating to projects and development application implication in relation to water and sewer as per the Council's customer service charter.
- Plan and manage the implementation of stormwater drainage plans and projects for the maintenance and construction of stormwater drainage infrastructure.
- Liaise with Water & Sewer Systems Engineer and provide input and support in regards to asset management of water, sewer and storm water drainage and development of Capital Delivery Projects.
- Monitor expenditure budgets for projects as provided by Council to ensure that jobs are completed within budget restraints and that annual expenditure is within budget.
- Prepare quotes and budget estimates for projects and maintenance as required.
- Monitor, collect evidence and document the construction works undertaken by contractors and developers for compliance with applicable specifications and standards

KEY MANAGERIAL ACCOUNTABILITIES (if Management role)

Relieve for the Water & Sewer Systems Engineer or Section Lead during periods of absence and demonstrate leadership qualities to ensure, productivity, team morale and effectiveness is achieved through support of staff.

- Extensive knowledge and experience in the investigation, planning, design, construction and operation of infrastructure (minimum 5 years)
- Extensive experience in project and contract management utilising established system for the delivery, coordination and management of operational/capital delivery work programs within water and sewer industry (minimum of 5 years)
- Demonstrated ability to prepare contract documentation, tender specifications and the ability to monitor and manage a budget
- Well-developed analytical skills and demonstrated innovative and flexible approach to problem solve project requirements
- Direct experience and associated skills in the management of staff, consultants, contractors and both internal and external stakeholders
- Highly developed oral and written communication and interpersonal skills and a proven ability to provide clear, well-constructed written and verbal advice
- High level computer literacy and knowledge of Microsoft Office Suite, GIS, Asset Information and project databases.
