## Primary Objective:

As part of a multidisciplinary team, plans, implements, coordinates and evaluates counselling and therapeutic services to Anyinginyi patients in the clinical specialty areas of Suicide Prevention, Trauma Grief and Loss, Abuse including Domestic Violence, Anger Management, Person to Personal Relationships, AOD use, some undiagnosed Mental Health issues and Pregnancy and Early Childhood Development using advanced clinical practice skills. Plan, Implements and evaluates patient safety and quality of care. Practices as a Therapeutic Worker and ensures practice is in accordance with either Australian Health Practitioner Regulations Agency (AHPRA) or the Australian Association of Social Workers (AASW) Practice Standards 2013 and Code of Ethics 2010 and/or the Society of Professional Social Workers code of ethics and SMHS policies and guidelines.

## **Context Statement:**

Anyinginyi Health Aboriginal Corporation is a multi – disciplinary Aboriginal community controlled organisation which provides primary health care services to the Aboriginal people of Tennant Creek and the surrounding Barkly region.

## Key Duties and Responsibilities:

## 1. <u>Clinical:</u>

- **1.1** Plans, implements and coordinates therapeutic services to Anyinginyi patients/clients in the clinic and community teams.
- **1.2** Undertakes triaging, assessment, treatment/intervention and evaluation at an advanced level of practice to Aboriginal individuals, families and groups with complex needs.



- **1.3** Advocates on behalf of Anyinginyi clients in the pursuit of a holistic services delivery framework of care to encourage both positive outcomes for individuals and families thought multi-agency work.
- **1.4** Actively priorities and coordinates own caseload including participating in clinical review meetings and case conferences as required.
- 1.5 Provides advanced clinical consultation to Anyinginyi staff.
- **1.6** Supports and liaises with patient, carers, colleagues, medical, nursing, allied health, support staff, external agencies and the private sector to provide coordinated multidisciplinary care.
- **1.7** Completes clinical documentation and undertakes administrative tasks as required to support clinical colleagues where relevant and necessary.
- 1.8 Participates in ongoing evaluation of clinical practice.
- 1.9 Undertakes clinical intervention in remote communities as directed.
- **1.10** Participates in department and other meetings as required to meet organisational and service objectives.
- **1.11** Contributes to the Connected Beginnings updating of the Tennant Creek Service Directory on an annual basis.

#### 2. Educational/Training/Research:

- 2.1 Engages in continuing professional development/educational and ensures continuous eligibility for either the Australian Health Practitioner Regulation Agency (AHPRA) or the Australian Association of Social Workers or the Society of Professional Social Workers.
- **2.2** Initiates, implements and participates in clinical research activities in consultation with the Health Services Section Manager to systematically evaluate service delivery and meet Anyinginyi client's needs where applicable.

#### 3. SMHS Governance, Safety and Quality Requirements

- 3.1 Participates in the maintenance of a safe work environment.
- 3.2 Participates in an annual performance development review.
- **3.3** Supports the delivery of safe client care and consumer experience at Anyinginyi including identifying, facilitating and participating in continuous safety and quality improvement activities, and ensuring services and practices align with the requirements of the National Safety and Quality Health Services Standards and other recognized health standards.
- **3.4** Completes mandatory training (including safety and quality training) as relevant to the role.
- 3.5 Performs duties in accordance with Anyinginyi specific policies and procedures.

# **Decision making**

# Selection Criteria

- Essential:
  - Tertiary qualification in Clinical Psychology or Social Work and eligible for full membership of either the Australian Health Practitioner Regulation Agency (AHPRA) or the Australian Association of Social Workers or the Society of Professional Social Workers.
  - 2. Demonstrated extensive relevant clinical experience and knowledge and advanced skills in appropriate assessment, treatment and evaluation in the clinical specialty areas of Suicide Prevention, Trauma, Grief and Loss, Abuse including Domestic Violence, Anger Management, Person to Person Relationships, AOD use, some undiagnosed Mental Health issues and Pregnancy and Early Childhood Development.
  - **3.** Demonstrated ability to plan, develop, coordinate, implement and evaluate services delivered by the Therapeutic Working including application of quality improvement principles and practices.
  - **4.** Demonstrated high level time management, administrative and organisational skills when planning, providing and monitoring Therapeutic Worker services.
  - 5. Demonstrated high level interpersonal, written and verbal communication.
  - 6. Demonstrated ability to work effectively in a multidisciplinary team setting.
  - 7. Current "C" or "C.A." class drivers licence.
  - 8. Current knowledge of legislative obligations for Equal Opportunity, Disability Services and Occupational Safety and Health, and how these impact on employment and service delivery.

- 2. Previous experience in a regional or remote health related setting.
