Position Overview:	The Individual Giving Coordinator - Face to Face is responsible for the day-to-day management of the face to face and related acquisition programs. The role is to recruit regular givers (Human Rights Defenders), whilst testing new approaches and fundraising techniques to ensure engaged donors are recruited and stewarded through a tailored supporter journey.
	This role takes on the responsibility for account management of face to face and other direct engagement third party suppliers.
	The Individual Giving Coordinator - Face to Face works closely with the Individual Giving Leads and Supporter Engagement on development of program strategy, budget re-forecasting and ensuring targets/objectives are met. They work closely with Contract and Facilities in ensuring rigorous negotiation and monitoring of our agreements with service providers.
	This program is a vital part of the organisation's fundraising mix, recruiting more than 10,000 Human Rights Defenders in 2019. The F2F program will be focused on strengthening relationships with our suppliers and key fundraisers, coordinating training sessions and rewarding and recognising outstanding fundraisers working on the program. The goal is to increase the quality of the donor experience leading to an increase the retention of our new donors.

- Drive innovation with new initiatives and ensuring the best practice internal processes for growth and efficiencies

- Performing the role to a high standard within agreed timelines, and in line with Amnesty International Australia's (AI Australia's) vision
