Burnet Overview

Burnet Institute is a leading Australian medical research and public health organisation focused on achieving better health for vulnerable communities in Australia and internationally by accelerating the translation of research, discovery and evidence into sustainable health solutions. The Institute is headquartered in Melbourne with programs that operate across Asia, the Pacific and in Africa.

Burnet's culture links innovative discovery-oriented research and implementation research with development and humanitarian action. World-class laboratory and field-based research is integrated into multidisciplinary programs aimed at the prevention, detection and treatment of diseases of global significance. This unique approach allows the Institute to make a tangible and sustainable impact on health in both developed and developing countries.

The Institute has three major thematic programs – Disease Elimination, Behaviours and Health Risk, and Maternal and Child Health, and two expansion programs – Healthy Ageing and Health Security. Staff within these Programs are supported by cross-cutting communities of practice; the disciplines of Life Sciences, Public Health and International Development.

Position Purpose:

The purpose of this position is to conduct nurse lead clinical research in a community and outreach settings involving interviews, liver fibrosis assessment and blood sample collection from participants with histories of injecting drug use and other at-risk populations in studies currently being undertaken at the Burnet Institute.

The main focus for this position will be The Hepatitis C Treatment and Prevention (TAP) Study: Hepatitis C treatment for people who inject drugs in a community–based setting using a social network approach.

This position is initially funded for a period of 12 month during which time the Research Nurse will conduct interviews with, and collect blood samples from, study participants, manage data collection as well as participate in the wider activities of the Burnet Institute.

Training will be provided in all aspects of the position and work will be undertaken under the supervision of the project investigators and clinical trial nurse coordinator.

The Research Nurse will spend most of their time in the field, which includes working from a mobile van conducting clinic research, and may also include working in general practice or community services (that is, outside of traditional hospital hepatitis research clinics). The nature of community work involves travel across greater Metropolitan Melbourne (i.e. Frankston, Geelong) using work provided vehicles and at times some flexibility with working hours is required to match the needs of study participants.

	Key Responsibility Areas			
1.	Participant recruitment	Assessing participant suitability for clinical trials (TAP study and EC Partnership). This includes recruiting, interviewing and viral hepatitis treatment initiation and following up of study participants. Interviews will make use of computerised data collection forms as per study protocols.		
2.	Blood sample collection	Collecting blood samples from participants as per study protocols. This includes the provision of appropriate counselling and education around blood borne viruses.		
3.	Liver Fibrosis Assessment and Treatment administration	Conducting fibroscans of the liver and working closely with specialists to ensure participants receive treatment and follow up care as per study protocols.		
4.	Data management	Upload data and manage collected samples as per study protocols.		
5.	Institute Participation	Attend relevant meetings as required.		
6.	Ethical engagement	Abide by our ethics procedures as outlined in the ethics protocols for the TAP study and other studies and Institute Standard Operating Procedures.		
7.	Other Research Tasks	These may include liaison with external agencies, the provision of advice to other Institute staff, conference attendance and presentation, assisting or leading research on related projects.
