ORGANISATIONAL ENVIRONMENT

PRIMARY OBJECTIVE

The primary purpose of this position is to;

- Deliver programmed bridge maintenance and minor construction works within predetermined time, quality and cost targets; and
- Provide sound leadership of a multi-skilled team, implementing best practice work methods whilst satisfying all statutory requirements.

KEY ACCOUNTABILITIES

- 1. Ensure that program works are completed within established time, quality and cost target, including;
 - Coordinating and undertaking scheduled works.
 - · Adopting best practice work methods on programmed works tasks.
 - Forecasting and co-ordinating the provision of labour, plant and materials.
 - Ensuring compliance with all statutory requirements.
 - Interpreting work requirements and undertaking quantity and survey calculations necessary to complete the works.
 - Ensuring appropriate plant type and capacities which are required to undertake the work are utilised on all projects.
 - Liaising with residents, members of the public, service utilities, contractors and other stakeholders during the course of the works.
- 2. Provide advice and assist in the development of maintenance works for bridges and culverts, including;
 - Project costing estimates.
 - Providing professional advice and technical input into bridge maintenance and replacement works programs.
 - Undertake bridge maintenance inspections as required.
 - Assisting in the development of Council's bridge works program.
- 3. Lead and manage the Bridge Maintenance team, including;
 - Coordinating the operational activities of all team members.
 - Assist in undertaking workplace assessments of team members in accordance with Council's policies.
 - Assisting with the development and training of team members.
 - Monitoring performance of team members and provide feedback as required.
 - Providing on-going feedback to the Maintenance Coordinator on the performance of team members.
 - Actively encouraging team harmony and cooperation and ensuring that a positive example is set for the team.
 - Undertake Performance Development Plan appraisal of team members.
 - Developing and maintaining a team culture which displays excellent work ethics and strives to continually improve to produce the best possible outcomes for Council.
- 4. Ensure that all works undertaken are in accordance with all relevant quality, environmental and WHS requirements.
- Maintain the health and safety of the general public and Council staff during the execution of works by ensuring safe work practices are adopted and adhered to in accordance with Council's WHS policy and procedures.

6.	Ensure a positive image of Council is promoted throughout the community through courteous, responsive and efficient service.
7.	Any other accountabilities or duties as directed by Supervisor/Manager which are within the employee's skill, competence and training.

POSITION SELECTION CRITERIA

- 4. Demonstrated ability to accurately calculate and measure material quantities and dimensions.
- 5. Demonstrated extensive experience in a civil maintenance and civil construction role, particularly in regard to timber bridges and civil works and the proven ability to undertake the 'hands on' duties.
- 6. Demonstrated solid written and verbal communication skills.
- 7. Demonstrated knowledge and understanding of Workplace Health and Safety requirements.
- 8. Demonstrated sound computer skills, including experience in the use of MS Office applications.
