DIVISION / UNIT / TEAM SUMMARY

The Strategy and Support Division works directly with people, clinicians, researchers and policymakers. Our purpose is to reduce inequities and improve outcomes for all people affected by cancer, now and into the future. Our division comprises of Cancer Information and Support Services, Research Governance and Business Operations, Cancer Strategy and the McCabe Centre for Law & Cancer.

We achieve our purpose by:

- Using evidence to investigate and evaluate policies and programs to support people affected by cancer
- Funding extramural cancer research of greatest impact and increasing investment into cancers with lowest survival

- Collaborating with partners in Australia and across the world to influence policy change and reduce system inequities

The Cancer Information and Support Service (CISS) unit provides information and support services to help minimise the impact of cancer on the Victorian community. It works to empower patients by delivering dynamic, credible, personalised information and compassionate support.

POSITION SUMMARY

The 13 11 20 National Projects Lead is primarily responsible for supporting projects that aim to increase awareness, uptake, and referral to our 13 11 20 service. The role is instrumental in providing project support to the Head of Division for the Commonwealth funded Australian Cancer Nursing and Navigation Program (ACNNP).

Reporting to the Head of CISS, and working closely with the Head of Division, the 13 11 20 National Projects Lead will lead project support for the ACNNP and other projects and special initiatives that arise within 13 11 20. The role will work collaboratively with key internal and external stakeholders to ensure work aligns with, leverages and supports concurrent state led projects underway in CISS and other areas of the Division, to maximise our ability to achieve our outcomes and overall strategic objectives.

RESPONSIBILITIES

Project Implementation and Coordination

- Establish an appropriate project structure to support emerging priorities of work within 13 11 20 including Cancer Council Victoria's contribution to the ACNNP.
- Apply project management methodology and tools to support development of detailed project plans with associated budget, milestones and deliverables, risk identification and mitigation, data collection and evaluation as required.
- Coordinate regular review of projects against milestones, manage and adjust for any changes in project scope, track budget and identify and mitigate potential risks to ensure projects are delivered on time and on budget.

Relationship Management and Collaboration

- Maintain and support ongoing engagement with project partners and key internal and external stakeholders, including those identified through the ACNNP.
- Work closely with the Strategic Projects Lead, under the leadership of the Head of Division and Head of CISS, to manage successful collaboration on projects and to create efficiencies and meet project objectives and deliverables.
- Assist teams within the Division and the Head of Division, with ongoing engagement activities to continue to raise the profile of 13 11 20 to existing and potential new stakeholders that will support increased uptake of 13 11 20 services.

Evaluation, Monitoring and Reporting

- Prepare relevant project data, reports, presentations and other documents for the Head of Division, executive and project stakeholders, in a timely and accurate manner.
- Meet regularly with the Head of CISS and Head of Division as required to report on project progress and mitigate any emerging risks.
- Identify opportunities to disseminate the project outcomes through publication, or conference presentation.
- Represent projects at meetings, including with external stakeholders, as required.

Such other duties as directed and consistent with an employee's level of skill, competence and training.
