### What's the focus of this position?

The Corporate Analyst is responsible for developing and leading an optimisation program that transforms business practices through strategic decisions that support short and long-term growth.

The Corporate Analyst is accountable for providing CN with accurate and timely qualitative and quantitative analysis and impart CN with actionable insights from relevant data. Their key focus is to evaluate data and business practices and offer sophisticated interpretations to drive success within CN and provide effective business solutions and opportunities.

### What you'll be doing:

- Work in an agile environment and investigate, analyse, review and document requirements for business improvement projects.
- Provide guidance to end to end project delivery by investigating operational needs, problems and opportunities and proposing solutions.
- Conduct detailed feasibility and cost benefit analysis (including financial modelling) to prepare initial statement of requirements / recommendations to proceed.
- Manage significant change management and business improvement projects from inception to completion with appropriate consideration of financial, strategic and cross-organisation impacts achieved through leadership, organisational knowledge, innovative solutions and stakeholder engagement.
- Analyse business information to provide historical, current and predictive views of business operations and timely retrospective service analysis to identify business opportunities.
- Identify, validate and exploit internal and external data sets generated from a diverse range of processes to forecast future activity, behaviour and trends.
- Elevate productivity and effectiveness of CN by delivering high-quality data assets and tools including
  the creation of statistical graphics, plots and information graphics to visually communicate quantitative
  messages to make data more accessible, understandable and usable
- Provision of accurate, timely and meaningful business performance reporting, including program and individual project reports and develop indicators that will enable the organisation to measure its success in improving and implementing processes to achieve sustainable excellence.

- Minimum of 5 years' experience in implementing improvements using Lean, Six Sigma, or other recognised process improvement methodology and techniques.
- Demonstrated project management experience with the ability to coordinate and manage multiple projects and resources effectively to achieve goals to meet planned targets, deadlines and commitments.
- Experience in managing complex datasets and conducting quantitative and / or qualitative statistical analyses including a demonstrated aptitude for understanding, manipulating and cleaning complex datasets.
- Strong conceptual and practical understanding of modern frameworks and methodologies such as Scrum, Kanban, lean, design thinking, human-centred design, multivariate testing, continuous improvement and test automation
- Well-developed business acumen and critical thinking skills with the ability to manage budgets, analyse data and compile reports.
- Ability to gain respect, integrity and trust through situational leadership and inspire others to follow and participate in change processes.
- Excellent communication and interpersonal skills demonstrated by abilities in consultation, negotiation
  and influencing skills at all levels, and the capacity to develop and manage effective relationships with
  all stakeholders and all levels of staff.
