#### What you'll be doing:

- Investigate and resolve complex road safety, traffic and parking issues including the provision of traffic facilities and guidance signage.
- Develop local area traffic management studies, investigate local road safety issues, develop concept designs, undertake public consultations, and provide detailed reports to the Local Traffic Committee and CN.
- Coordinate and manage delivery of multiple projects across the region.
- Investigate, develop and prepare submissions for external funding grants such as Blackspot Program and Safer Roads Program to RMS and other organisations Perform traffic analysis and modelling utilising computer simulations (SIDRA), and similar complex analysis requiring traffic expertise.
- Provide technical knowledge and guidance to internal stakeholders within CN in the delivery of internal CN projects, to ensure compliance with all statutory requirements and guidelines.
- Undertake strategic road network planning which emphasises road safety, network efficiency, and
  residential amenity and coordinate with state government bodies to provide safe and cohesive transport
  arrangements throughout the city.
- Manage the requirements and approvals of external bodies for the occupation and use of CN road space.
- Coordinate the development and approval of traffic management plans for community events and provide balance between community access and event requirements.
- Provide specialist technical advice to senior planners in the review of construction management plans, development application matters, and other requirements associated with traffic generating developments.
- Contribute positively to a co-operative and supportive multi-disciplinary team environment and maintenance of an overall team performance objectives.
- Assist the Traffic and Transport Coordinator in mentoring, educating, supporting and training team members in work procedures and relevant standards and guidelines.
- You will be required to carry out other duties that are within the limits of your skills, competence, training and/or experience as directed by your Manager.

#### The essentials you'll need:

- Bachelor's Degree in Civil Engineering or Traffic Engineering or relevant industry qualifications (eligible for Chartered Professional Status with the Institute of Engineers Australia).
- Significant demonstrable experience in traffic engineering or equivalent, including extensive knowledge
  of traffic legislation, procedures, and statutory instruments.
- High level verbal and written communication skills, and demonstrated problem solving skills in real world environments.
- Relevant experience in a Local Government context, including experience in preparation and presentation
  of high quality reports to Councillors, state agencies and stakeholders, and an ability to handle sensitive
  / controversial issues within a community context.
- Extensive experience in the interpretation of traffic data and modelling software (SIDRA), including
  accidents, intersection capacity and safety and blackspots, and knowledge in the conceptual design of
  traffic management devices, intersections, and road geometry.
- Experience in civil design requirements for roads and intersections.

- Experience in the development of large scale Local Area Traffic Management plans, based on traffic surveys, community expectations and integration with roads authorities.
- Involvement in the assessment of traffic impacts associated with development applications and other traffic generating developments.
- Demonstrated experience in the design and review of traffic control and traffic management plans for road occupation for construction or event purposes, including current Code of Practice. Temporary Traffic Management.
- Class C drivers' licence.
