Our team is a mix of administrative staff and tradespeople who ensure the delivery of whole of life fleet services and oversee the operational management of the Waratah Depot site. We believe that by empowering and developing our team we achieve innovation and best support our customers.

What's the focus of this position?

This position is responsible for managing the safety and compliance of CN's fleet assets, from concept through to disposal. The primary focus is to ensure CN's fleet assets comply with the National Heavy Vehicle Accreditation Scheme (NHVAS) and maintain the accreditation through the provision of safety inspection audits, document management and the coordination of annual fleet registrations.

What you'll be doing:

- Collate and administer relevant documentation to maintain CN's NHVAS accreditation and report back to management with recommendations, changes or alterations to manage the risk of noncompliance of CN's operations and safety standards.
- Coordinate and facilitate all internal and external compliance audits with the required stakeholders to ensure conformity to requirements and continual improvement.
- Undertake duties as a Mechanical Tradesman to support mechanical workshop operations as directed by the Workshop Manager.
- Coordinate and manage the registration of all motor vehicles within CN's fleet in accordance with Roads and Maritime Services (RMS) safety and compliance requirements.
- Provide legislative advice and improvement recommendations on Vehicle Safety during the tendering process and commissioning of CN fleet.
- Coordinate and undertake routine crane and hoist inspections (fixed plant) in all CN workshops and manage mobile plant crane compliance and inspections in-line with schedule and safety standards.
- Consult with Fleet Management during fleet commissioning, and provide advice, while completing all required WHS and CN documentation
- Facilitate the implementation of vehicle weighing systems (Loadcells) for CN fleet, ensuring safety compliance through inspection and calibration.
- Manage inspections and compliance for RMS G22 certification for all relevant CN fleet assets
- Manage daily vehicle inspection documentation ensuring operator compliance for CN plant items through regular audits and reporting to management.
- Provide consistent and accurate advice and support to stakeholders in the management of contractor fleet compliance to specified standards.
- You will be required to carry out other duties that are within the limits of your skills, competence, training and/or experience as directed by your Manager.

The essentials you'll need:

- Relevant mechanical trades qualifications and experience as a mechanical technician.
- Light and heavy AIS Examiners and Proprietors Certificate.
- Approved Plant Inspector Certificate (RMS G22).
- Experience in electronic, hydraulic and air pressure systems diagnostics and repairs, along with calibrating and inspecting vehicle weighing systems.
- Previous experience commissioning and reviewing vehicle safety compliance and WHS documentation.
- Extensive experience using software and systems and/or Microsoft suite.
- Valid HR Driver's licence.
- Ability to perform allocated duties with minimum supervision.
- Knowledge of relevant Work Health and Safety requirements.
- Ability to work in a team environment, contribute to team objectives and focus on continuous improvement.
- Literacy and numeracy skills adequate to meet the requirements of the position.

Other valuable skills you may have:

- Experience in Vehicle specification tender documentation development.
- Experience in TechOne suite of programs.
- Experience in safety/ incident investigations.
- Ability to participate in an on-call roster.
