## What is the focus of this position?

The Road Maintenance Manager provides leadership and management to the Road Maintenance Service Element. This role ensures the delivery of civil infrastructure maintenance of the road network, piped and natural drainage assets and ancillary facilities on local roads, public reserves and foreshore areas that is cost effective, timely and meets the quality expectations of City of Newcastle. The Road Maintenance Manager is a member of the Civil Construction and Maintenance leadership team and will play an active role in the management and culture of the Service Unit as a whole.

#### What you will be doing:

- Manage the Road Maintenance Service Element to deliver the Road Maintenance program using internal and external resources within budget, to CN standard and in a timely manner.
- Lead, motivate and manage a team to deliver significant, complex and / or politically sensitive projects / programmed services requiring strong leadership to meet stakeholder expectations.
- Foster a culture of safety and innovation through continuous improvement and change management to develop best-practise work processes and Quality, Safety and Environment (QSE) management systems.
- Establish and maintain professional working relationships with internal and external stakeholders and actively model and advocate CN's CREW values of Cooperation, Respect, Excellence and Wellbeing, to produce successful outcomes.
- Develop and manage the service element's allocated Operational and Capital Works budget aligned to strategic and operational priorities, focused on efficiencies, value for money and quality objectives.
- Provide technical advice to stakeholders in line with local government legislation, including the preparation of GIPA reports, DA referrals, insurance investigations and councillor requests.
- Perform people management activities including recruitment, training, performance management and annual performance development plans, with the assistance of People and Culture where necessary.
- Monitor procurement and contracts to ensure the Construction team compliance to CN procurement policy.
- Provide expert advice on matters of public liability within public places.
- Any other accountabilities or duties as directed by the Executive your Manager / Director which are within the employee's skill, competence, and training.

- High level people management skills, with demonstrated success leading a team to be capable and accountable through effective coaching and performance management.
