Environmental/Psychosocial Factors

- Approximately 50% of work tasks are performed within an office environment this can include but is not limited to computer data entry and reporting.
- Approximately 50% of tasks are performed on site. This includes site inspections of a variety of different sites ie. Restaurants, kitchens, pools, hair and beauty salons, private property, rural sites etc.
- Environmental Health Officers work autonomously and are required to meet deadlines and service level expectations. If environmental health officers are aware they are heading into a potentially dangerous or abusive situation they are required to take a team member with them.
- To ensure accurate results site inspections are unscheduled. Environmental Health Officers enter peoples businesses unannounced to assess compliance with the relevant regulations. At times this results in business owners that may react disrespectfully, angrily or argue certain points. Environmental Health Officers are required to stay calm, explain problem areas, educate and offer solutions to ensure business owners comply with regulations.
- Is exposed to all weather conditions and may work in uneven/sloped terrain and slippery/muddy ground surfaces (gum boots are available for use). The work area may be surrounded by water and hazards may be present.
- Required to deal with complaints from members of the public and deal with these in an effective and time efficient manner. They may be involved in investigating complaints that are subject of neighbourhood disputes, resulting in aggressive customers and potentially dangerous situations.
- Environmental Health Officers enforce a number of regulations which include: Food safety regulations, public health regulations, swimming pool regulations etc.
- May be required to perform overtime and may be called out for emergency situations. However, this is only required on an intermittent basis.

Inside work	Yes	When performing office based tasks and when performing site inspections in buildings, factories and facilities.
Outside work	Yes	When performing inspections ie. Quarries, river, public areas.
Night work	Yes	Workers may be called out at night for emergency situation when on call, and when required for investigations but this is required rarely.
Extreme heat	Yes	
Extreme cold	Yes	Exposed to a variety of weather conditions.
Humid or wet	Yes	<u> </u>
Noise	Yes	Workers may be exposed to machinery/production noise when performing site visits. They may also be exposed to general traffic and plant noise when on site.
Vibration	No	Not applicable.
Mechanical hazards	Yes	The worker may be exposed to traffic, plant machinery and equipment/machinery when performing site visits.
Electrical hazards	Yes	The worker may be exposed to electrical hazards when performing site visits and/or when inspecting building projects.
Risk of burns	Yes	Taps are heated prior to taking samples and inspecting kitchen/industrial premises.
Radiant energy	Yes	When performing site inspections/visit in outside areas. Sun protection is worn.
Poor ventilation	Yes	Poor ventilation may be experienced when performing inspections on site.
Moving objects	Yes	The worker may be exposed to traffic, plant machinery and moving equipment and/or machinery when performing site visits.
Sharp tools	Yes	Knives
Cluttered or slippery floors	Yes	The worker may be exposed to cluttered/slippery work environments when performing site inspections. They are also required to take water samples and the surrounding area may be muddy and/or slippery.
Elevated surfaces	Yes	The worker may be exposed to elevated surfaces when performing site visits and/or building inspections. Ie. Cooling towers.

Lighting	Yes	The level of lighting varies at each site and the area may be either dimly lit or bright.
Exposure to fumes/odours/ dusts/mists/ gases	Yes	Exposure may occur at site visits and/or within emergency situations. However, the worker is trained in this area to ensure safety. May include natural gas, mould garbage.
Exposure to biological hazards	Yes	Exposure may occur at site visits and/or within emergency situations. However, the worker is trained in this area to ensure safety. May include septic tanks and sharps.

Vision	Yes	Vision is required when performing computer based and administrative duties. Vision is also required when driving to/from site, when performing inspections and taking samples.	
Hearing	Yes	General liaison with other workers and members of the public is required and the worker also needs to be aware of surrounding traffic, plant and equipment when on site.	
Speech	Yes	General liaison with other workers and members of the public is required. Skills in dealing with irate customers required.	
Reading	Yes	Completion of paperwork as required.	
Writing	Yes	High levels of report writing skills required.	
Numerical ability	Yes	When calculating samples and for reporting purposes.	
Smell	Yes	Required for environmental health ie odour control.
