Environmental/Psychosocial Factors

- Gardeners working a team environment
- Gardeners work outside and are exposed to all weather conditions, uneven/sloped terrain and slippery/muddy ground surfaces may also be traversed at times. Snakes and spiders may also be present in the vicinity of the work area.
- At times work will be conducted in high traffic areas.
- May have to deal with complaints from members of the public and deal with these in an effective and time efficient manner. Also needs to be aware of the public utilising the sporting fields and parks where work is being undertaken.
- May be required to perform overtime and may be called out for emergency situations. However, this is only required on an intermittent basis.
- It should be noted that Parks and Landcare has a peak period in summer and an off peak period in winter, while employees work their set hours every week in the peak period team leaders are required to juggle a higher demand for their services and may experience increased requirement for overtime.

Lifting from chest level while reaching in an extended position and rotating in the trunk. Lifting ranges from ground to knee to waist to shoulder to overhead.
	10-20kg	Occasional	Lifting the push mower and the edger onto or off the truck. Usually a two person task. Lifting ranges from ground to knee to waist to shoulder to overhead.

	>20kg	Occasional	Lifting aids or a team lift are generally used for heavier plants and equipment.
Carrying	5-10kg	Frequently	Carrying plant and equipment from truck to worksite. Using the wipper sniper, blower, hedge trimmer etc Gardeners are required to hold these pieces of equipment for a sustained period of time while walking, rotating their trunk. Equipment must be held out from the body. Gardeners use a harness when using the wiper sniper.
	10-20kg	Occasional	Carrying chemical spray back pack on shoulders for chemical application.
Pushing/pulling	Force varies, usually light	Occasional	Exerting light forces to operate the push mower. Usually sustained for prolonged periods.

Brush Cutter/Wiper sniper	8kg	Repetitive and frequent rotation of the neck, shoulder and pelvis when brush cutting.
Edger	Approx 20kg	Used occasionally for up to an hour at a time.

Hedge trimmer	5-10kg	Requires awkward extended reaching against resistance to hold the tool away from the body and at the correct position to do proper cutting.
Pole saw	8kg	The pole saw is used with the upper extremity extended and causes strain on the body due to the leverage.
Chain saw	6kg	Used occasionally.
Ride On Mower	Not determined	Operated occasionally, sometimes for prolonged periods.
Mulch fork	2kg	The weight will vary depending on the load placed on
Shovel	2kg	the tool.
Spraying back pack	10-12kg when full	Lifted onto back, usually using a two handed motion. This procedure involves rotation of the spine. The pull of the backpack straps over the shoulders could place strain on the neck and shoulders when carried for prolonged periods, especially when associated with looking down.
Blower	Not determined	Repetitive wrist movements may cause strain on the upper extremity due to swinging the blower repetitively and with force while pronating and supinating the wrists and doing ulnar and radial deviation.
