This is a hands-on role requiring you to complete a variety of work in areas relating to grounds maintenance. You will be rostered according to the operational need at the time; hence you will need to be flexible and willing to work when required at any of our Community Business locations within the region.

A General Hand with Flourish Australia's Community Businesses is required to work alongside supported employees, acting as a role model for people with differing levels of skills and expertise therefore your sensitivity to, and empathy for, people with a lived experience of a mental health issue will be essential.

You will need to be a caring and understanding individual with good communication, interpersonal and customer service skills. Assistance will be readily available via the on-site Supervisor.

- Will be required to help supervise the loading and unloading of machinery, tools, vehicles and equipment.

Required Skills and Personal Attributes

To be successful in this role, General Hands, Grounds Maintenances are required to:

- Work independently, and as part of a team.
- Obtain working knowledge of Flourish Australia programs.
- Apply emerging working knowledge of recovery-oriented practice.
- Have good interpersonal skills, be non-judgmental, be fair, patient, have a willingness to listen, and display empathy.
- Be people focused and work in partnership.
- Value diversity and be respectful at all times.
- Be committed to professional and ethical conduct.
- Effectively organise and plan the work day.

Key Selection Criteria

"Flourish Australia supports Affirmative Action. If two candidates present with suitability to a role, and one of those people has a lived experience, the person with the lived experience will be the preferred candidate."

Essential:

- 1. Ability to work empathetically with persons with a mental health issue.
- 2. Ability to work and proceed with routine supervision.
- 3. Ability to communicate effectively in written & verbal communication.
- 4. Ability to apply common sense in dealing with everyday work practices.
- 5. Confidence to successfully work with and motivate a team.
- 6. Green card/White card (where required).
- 7. Current Australian Driver's Licence.

Desirable:

- 1. Knowledge of the challenges and barriers people who live with mental health issues may face in trying to join the workplace will be highly regarded.
- 2. A carer role or a personal lived experience of a mental health issue will be highly regarded.
- 3. Relevant qualifications or experience in horticulture (or willingness to obtain).
