# The George Institute for Global Health

We are a medical research institute affiliated with leading universities aiming to challenge the status quo in health care. With 700+ people around the world, and projects in over 40 countries, our Strategy 2025 is all about impact – specifically, the impact of The George Institute's activities on the health of millions of people, particularly those living in disadvantaged circumstances around the world.

Our strategy focuses on three key research priorities:

- Better Treatments: finding better treatments for the world's biggest health problems
- Better Care: transforming primary health care to support better health for more people
- Healthier Societies: harnessing the power of communities, governments and markets to improve health

Our innovative commercial enterprises help maximise our impact.

Here is a sample of the things we are doing to achieve our goal of having the greatest possible impact on global health:

- We are identifying better and safer treatments for our biggest killers like stroke, heart disease and high blood pressure;
- In many countries, our award winning FoodSwitch smartphone app is helping people make healthy food choices when shopping;
- In China, we ran a successful education and awareness program to reduce the amount of salt eaten by people by 25% each day
- In rural India, we have shown that mobile technology can help diagnose mental health, as well as help treat cardiovascular disease, and we're looking at similar approaches to treating chronic diseases in Indonesia and China;
- Together with Aboriginal communities in NSW, Australia, we developed an innovative community led program to assist young Aboriginal drivers attain their license, now implemented in a dozen of locations;
- We are developing an affordable dialysis machine, with potential to save millions of lives each year and transform the way kidney disease is treated globally.

The Global Advocacy, Policy Engagement and Thought Leadership (GAPETL) program aims to support the achievement of the research impact goals set out under the strategic research priorities by:

- Supporting a focus on impact within TGI from the earliest stages of research, by increasing
  awareness and understanding of the policy environment, and supporting researchers to develop
  meaningful 'pathways to impact';
- Facilitating coordinated engagement with policymakers and other key stakeholders, including developing and/or strengthening relationships with potential partners and collaborators; and
- Promoting evidence from TGI's research that has clear and specific implications for policy and/or practice, and advocating for change in line with those implications.

#### The Role

The George Institute seeks to employ a Policy and Advocacy Advisor (UK and Multilaterals) who will divide their time between a programme of advocacy and engagement with multilaterals and other global health organisations (50%), and policy engagement and advocacy in the UK (50%), with the aim of increasing the impact of the institute's research.

The position holder will work as a member of the global GAPETL team, which spans the UK, India and Australia and links with colleagues in China. They will work directly with TGI's researchers in the UK and elsewhere, and build relationships with counterparts at Imperial College London (ICL), with which TGI UK works in collaboration. They will also develop and strengthen relationships with key global health stakeholders in Europe, the US and elsewhere.

### Responsibilities

- Lead the development and implementation of an advocacy and policy engagement strategy in the UK, aligned with strategic research priorities and GAPETL team objectives
- With the GAPETL Director, implement a programme of engagement with multilaterals including the WHO and other UN agencies, global health organisations and advocacy networks, developing mutually beneficial relationships with key stakeholders to ensure impactful outcomes
- Lead engagement with UK government, health bodies, NGOs and other stakeholders to increase the impact of TGI's research, including through advocacy networks
- Conduct advocacy activities focused on the UK and multilaterals such as the G7 and G20, working with engaged senior leaders at TGI as appropriate
- Maintain an awareness of developments in the global health sector in the UK and globally, and advise senior staff on advocacy and engagement opportunities and challenges
- Use sector knowledge and experience to develop advocacy materials and activities promoting evidence from TGI's research that has clear implications for policy and/or practice
- Work with colleagues in the GAPETL team to identify opportunities for collaboration across regions and amplification of activities at the global level
- Work with UK-based researchers to develop meaningful pathways to impact for their research, including through drafting relevant sections of funding proposals, conducting stakeholder mapping and identifying capacity-building opportunities
- Secure funding through the inclusion of advocacy/policy engagement activities in successful
  research applications, and by winning commissions for standalone advocacy/policy engagement
  activities, including with multilaterals
