#### **Key Accountabilities**

- Lead the provision of healthcare with a focus on safety and quality to meet or exceed the National Safety and Quality Health Service Standards.
- Provide effective clinical leadership and support to Medical Practitioners, Dental Practitioners, Allied Health Professionals and diagnostic services in the provision of healthcare at GEO locations.
- Assist in the recruitment and selection of contracted Medical, Dental, Allied Health and Diagnostic service providers, coordinate and clinically oversight and monitor the provision of their services aligned to contractual requirements and as set out in the Primary Healthcare Performance Framework.
- Lead and coordinate the credentialing and appointment of employed and contracted Medical, Dental, Allied Health and Diagnostic staff and lead and/or participate in relevant credentialing and appointment committees.
- Participate in the GEO annual business planning process to ensure medical, allied health, dental and diagnostic services at each location are managed in accordance with the annual budget.
- Coordinate support and provide clinical supervision to Nurse Practitioner candidates and participate in the Nurse Practitioner Network.
- Lead Network meetings for Medical Practitioners, Dental Practitioners, Allied Health and Diagnostic staff and/or contractors.
- Assist in the implementation of the GEO Clinical Governance Framework and lead and participate in GEO Healthcare clinical governance committees as required.
- Assist in the development, implementation and monitoring of clinical policy, procedures and local operating instructions, associated with Medical Dental and Allied Health Services.
- Lead the management of medications at GEO Healthcare locations and develop and implement the GEO Healthcare Medication Formulary providing feedback on its use to the Pharmacy and Consumables Committee.
- Develop and maintain strong working relationships with the client and be a point of contact on matters associated with the provision of Medical, Dental, Allied Health and Diagnostic services by GEO Healthcare.
- Coordinate the development of medical reports for the client and external agencies within the required timeframes.
- Participate in key meetings with the client as contractually required and other meetings when requested to attend.

- Extensive experience in the development, implementation and monitoring of clinical policy, procedures and practice relating to medical, dental and allied health services.

- Satisfactory completion of a National Criminal History Check.
- Ability to obtain and maintain a security clearance.
