#### **Overall Purpose/Aim:**

To take a high profile and leadership role in the team and provide appropriate levels of line management, supervision, support and training to Social Workers and Children & Young Persons Support Service (CYPSS) Workers to ensure that high quality practice is an achievable aim for all Social Workers in line with Key Assets Fostering and the group's Vision and Values.

#### **Core Tasks**

#### **Team Manager Accountabilities**

- Show clear leadership within the social work team by working in close liaison with the Manager Social Work Services / Operations Manager
- Deputise for the Manager Social Work Services/Operations Manager in their absence
- Demonstrate a high level of knowledge, skills and expertise in Social Work practice
- Allocate work and tasks to Supervising Social Workers and chair relevant meetings, both internally and externally, as required.
- Ensure that Social Work Practice in relation to quality assurance and best practice is maintained in all cases and at all times
- Work closely with the Operations Manager / Manager Social Work Services to ensure that the social work team is appropriately resourced, managed and supported
- In conjunction with the Operations Manager / Manager Social Work Services monitor the compliance in relation to Case Plans, Placement Agreements, Health and Education Plans, Foster Carer Renewals, WwC checks (or equivalent) and medicals are up to date and on file
- Develop a close working relationship with the Options Coordinator for the development and implementation of care packages
- Keep up to date with best practice in relation to established practice, policy and research
- Assist Social Workers with complex cases
- Carry a small protected case load, as and when required
- Provide practice learning opportunities including supervision and support of students on placement
- Take a lead role in the delivery/planning of core training for Foster Carers and "Quality Care Training for foster Carers"
- Take a lead role in the professional development and training of Social Workers
- Take responsibility for the recruitment and retention of Social Workers in the team
- Ensure the on-going professional development of team members.
- In conjunction with the Operations Manager / Manager Social Work Services, ensure that all Carers
  within the social work team have an accurate and up to date Form 3A or Form 3B Assessment
  available that meets the needs of licensing, internal compliance and customers and ensure these
  are updated these as appropriate and in accordance with policies and procedures

#### **Staff Leadership Responsibilities**

• Take lead responsibility for the induction, supervision, line management, training and development of supervising social workers and CYPSS Workers, as required.



- Ensure that supervising social workers have access to appropriate levels of support and supervision in order to fulfil their responsibilities and meet the expectations of the agency and their profession
- Through high quality supervision, monitor and assess social work performance against agreed standards both internally and externally
- Take appropriate action to raise social work standards where performance falls below an acceptable standard
- Assist social workers to work through the emotional and personal demands the job places upon them
- Act as, Coach, Mentor and Advisor to other staff in the Team
- Ensure Social Workers have easy access to Agency policies and procedures as well as academic policy and research in order to analyse situations, make judgements and come to decisions.

#### **Business and Commercial**

- Meet and liaise with the Department of Communities representatives, as appropriate to discuss placement options and packages of care
- Represent KAF in a business capacity
- Contribute towards the growth and development of the business by implementing key areas identified in the business plan agreed through supervision
- Demonstrate a sound knowledge of the different placement packages and identify recharges where appropriate.
- Promote the benefits of the total range of services through Key Assets.

### **Supervision & Support of Foster Carers**

- Be involved in the Recruitment, assessment and on-going monitoring of the suitability and competence of Foster Carers ensuring they provide a safe, healthy, nurturing and learning environment for children/young people, as appropriate.
- Ensure that carers fully understand the fostering task, competencies to be achieved and the standards expected, including complaints and representation procedures as detailed in the KAF policies and procedures.
- Provide support visits and telephone contact with Foster Carers, in keeping with the placement agreement, including minimum bi-monthly or monthly supervision, as required.
- Work in partnership with all professionals to identify any needs within the foster family e.g. respite, activities, therapy, holidays, with all members of the child's network, including contributing to all relevant meetings and any other tasks defined
- Ensure each child has an accurate and up to date Case Plan on file and that Carers have a copy available for reference
- Ensure each child has a placement agreement on file and that Carers have a copy available for reference if appropriate
- Undertake Foster Carer renewals of approval, within required timescales, providing written evidence of competence. Present Renewal Reports to the KAF Review Panel, as required.
- Identify learning and development needs of Foster Carers and recommend action as required.
- Co-facilitate training modules for Foster Carers and attend, participate in and coordinate carer support groups
- Attend and/or arrange meetings to support Foster Carers, children and young people.
- Take a lead role in the resolution of any disputes arising between Foster Carers and other professionals.
- Support Foster Carers in preparing children and young people for independent or semiindependent living.
- Ensure Foster Carers are aware of wider support systems available e.g. Foster Care Queensland.



#### **Safeguarding Children and Young People**

- Work in partnership with the Department of Communities to ensure that the child and young person's needs as identified in the Case Plan and placement agreement are met.
- Ensure that comprehensive case recordings are completed and maintained.
- Demonstrate and ensure that the team has a sound knowledge of child safeguarding and reportable conduct procedures.
- Participate in negotiation between KAF and the regional Placement Services Unit to ensure that
  each child or young person placed is carefully matched with a Foster Carer capable of meeting their
  needs.
- Ensure the follow through of paperwork and procedures in relation to Critical Incidents and Notifiable Events to relevant parties.
- Ensure the necessary Risk Assessments are completed in line with KAF policies and procedures.
- Ensure compliance with licensing requirements.
- Attend social, educational and leisure activities relating to the support of children, young people and Foster Carers.
- In consultation with line manager, ensure that learning and development needs meet the requirements of professional development
- Participate in the Out of Hours duty rota.

#### Administration

- Take responsibility for administration in relation to the social work team to include file administration, producing typed communication and documentation as appropriate, reports and case recordings and comply with database compliance policies and procedures ensuring that all requirements of the database system are met
- Undertake File Audits within the Social Work Team and ensure that all KAF and DoC's paperwork is completed and on file at all times.

## **Additional Duties**

- The post holder will be expected to demonstrate that Key Assets *Values* are at the centre of all they do.
- The post holder will be expected to undertake training and development deemed necessary for the pursuance of the post
- The post holder will be expected to reach a minimum basic standard of I.T. competence to be able to use Company electronic systems effectively
- The post holder will be expected to ensure to comply with Equal Opportunities Policy and Procedure in all employment practices
- The post holder will be expected to comply with the no smoking policy in place and ensure that Health and Safety is observed in the course of employment
- Ensuring compliance with safeguarding procedures, throughout all work within the Company, keeping the State Director/ Operations Manager or equivalent informed of work in progress and inform the State Director/ Operations Manager or equivalent immediately of any child protection matter, reportable conduct or serious complaint.

It is the nature of work of KAF that tasks and responsibilities are, in many circumstances, unpredictable and varied. All staff are, therefore, expected to work in a flexible way when the occasion arises where tasks are not specifically covered in the Job Description and have to be undertaken.

# KEY ASSETS FOSTERING IS PART OF CORE ASSETS, THE CHILDREN'S SERVICES GROUP

The Company is registered with the Commission for Children & Young People and Child Guardian and makes use of their Working with Children Check Services, which facilitate the checking of individuals' criminal records by employers where such individuals are to occupy positions with access to children and young people. You will be required to consent to and apply for a Working with Children Check at regular intervals during your employment in this post and any offer of employment is provisional and conditional on the satisfactory outcome of the Working with Children check. The Company will be notified that the Working with Children Check has been issued and whether the check is 'clear' or contains information of 'criminal history'. Therefore when the Company receive a notification from the commission that the check contains information of criminal history a risk assessment will be completed to facilitate the decision making for suitability of employment.
