- Check engineering designs provided by Consultants, Design Engineers, Graduate Engineers and Student Engineers, ensuring compliance with Council policy, engineering standards and codes of practice.
- Manage consultants engaged to undertake civil design projects that form part of the annual capital works program, including procurement, evaluation and contract administration in accordance with Council's Procurement Policy.
- Arrange, coordinate and review geotechnical investigations, engineering surveys. CHMPs, Ecological studies and Planning approvals for allocated projects within the capital works program as required to ensuring timely completion for construction.
- Manage Design staff to thoroughly investigate customer requests such as drainage and stormwater flooding issues in a timely manner and develop and implement solutions in accordance with industry best practice, Council policy and budgetary requirements to ensure Council is pro-active and responsive to community needs and expectations.
- Provide best possible customer service to both internal and external stakeholders.

### 6. Accountability and extent of authority

- Prepare and develop engineering related Council policies, procedures and guidelines.
- Deliver the engineering design program and contribute to the development of the long term capital works program.
- Provide strategic advice and guidance to the Manager Engineering Services and Design and Infrastructure Coordinator on assigned and potential projects.
- Adhere to Council policies/criteria and sound engineering principles.
- Keep up to date with developments in legislation, acts, regulations, Australian Standards and guidelines that relate to engineering.



- Oversee the allocation of design resources to ensure the delivery of the capital works program in timely and cost efficient manner.
- Represent Council with various stakeholders and at various forums, networking events and meetings.

# 7. Judgement and decision making

- Policy interpretation and the necessity to recommend further policy development based on day-to-day experience with operations.
- Recommendations made to Design & Infrastructure Coordinator on matters not currently within budget parameters and policy/procedural guidelines.
- Solve technical problems and undertake original investigations.
- Exercise initiative skill and judgement, without guidance from others, in the provision of specialist advice on policies in relation to Civil Engineering Design.

### 8. Specialist skills and knowledge

- Detailed understanding of engineering design and construction techniques, to facilitate the

- Highly developed skills in civil design, in particular, road, intersection and drainage design with detailed knowledge of the engineering standards, codes and practices so as to apply these.
