Job Context

Gladstone Ports Corporation (GPC) manages and operates three ports, involving a number of differing work sites. GPC, and its wholly owned subsidiary Gladstone Marine Pilot Services Pty Ltd (GMPS), employ a diverse workforce of over 750 employees operating across multiple functional areas on a 24hr, 7 day basis.

The Port Strategy & Development department is accountable for the development, implementation and management of GPC's port services including pilotage, vessel schedules, Port of Bundaberg and Port Alma centres, Environment, Port Security and the provision of engineering services to facilitate GPC's future development and growth.

Job Purpose Statement

Conduct safe and efficient pilotage of vessels in the Gladstone region through the direct application of a high level of ship handling skill, local port knowledge and general maritime expertise.

Job Accountabilities

- Undertake training to gain a valid pilot licence and area endorsement, and to perform the duties of a pilot to meet the operational demands of the region;
- Undertake Continuous Professional Development training as stipulated by the regulator and required by GMPS to ensure maintenance of the highest professional standard in pilotage;
- Conduct safe and efficient pilotage of vessels in regional ports through the direct application of a high level of ship handling skill, local port knowledge and general maritime expertise;
- Undertake safety training, updating and familiarisation and marine emergency;
- Assist in the overall task of port pilotage management, including completion of appropriate documentation and logs in a timely manner;
- Work a roster specific to Gladstone region and form part of a team of pilots that work together to deliver pilotage services;
- Progress through a number of competency levels as professional skills and port specific knowledge is developed to the level of Senior Marine Pilot;
- Work towards achieving financial responsibility through identification of cost saving measures and effective utilisation of resources;
- Comply with all the Health, Safety and Environment management system requirements;
- Comply with GPC's Code of Conduct and lead by example GPC's values and guiding principles:

Growth, Prosperity, Community


