Management of best practice regulation of horse syndication, licensing and ownership, including in respect of Racing Victoria's role as ASIC-delegated Lead Regulator of horse racing syndicates.

Conduct consultations with relevant stakeholders in relation to major integrity reform projects.

Liaise with external regulatory bodies, including the Office of the Racing Integrity Commissioner.

Legal advice in relation to integrity-related media strategies and responses.
