Corporate Tax Manager

Business Unit: Finance & Commercial Services

Reporting to: Financial Controller

Position Purpose

The Corporate Tax Manager is responsible for directing the Company's tax compliance functions and all matters concerning tax planning, advisory and strategy in line with relevant state and federal tax laws and regulations. As the single internal tax specialist and key point of contact for internal stakeholders and external authorities for all tax matters, they are accountable for the development of the organisation's tax strategies, policies, systems & processes while putting safety first.

Key Accountabilities

- 1. **Safety:** ensure all activities are undertaken with the safety of our people as the number one priority and always role model safe behaviour.
- 2. Values: behave and make decisions in accordance with the WaterNSW Values at all times.
- 3. Assess the organisation's current tax practices, prioritise and make recommendations to enhance the control framework and lead the implementation of solutions to mitigate risk.
- 4. Lead the development and implementation of tax policies and procedures that support Water NSW group to achieve tax compliance in line with relevant taxation laws.
- 5. Manage the internal and external audit on tax matters, including implementation of action items arising from audits.
- 6. Act as the subject matter expert, providing the business with advice on all tax matters (including employment taxes e.g. superannuation, PAYG, payroll tax) and proactive analysis of new or changed tax legislation to understand the impact on the group.
- 7. Provision of strategic tax advice to key stakeholders across the organisation to minimise non-compliance, whilst at the same time minimising tax liabilities within the bounds of the relevant tax laws.
- 8. Accountable for the preparation and lodgement of all tax reporting in accordance with relevant laws and regulations. This includes Income Tax Returns (NTER), Fringe Benefits Tax Return, Business

- Activity Statements (GST and Fuel Tax Credit Rebates), Payroll Tax, Taxable Payments Annual Report (TPAR) for all relevant entities.
- 9. Responsible for the delivery of tax accounting business as usual activities including managing tax payments, preparing Tax Effect Accounting requirements, executing month and year end tasks (e.g. preparation of tax disclosure notes), income tax forecasting, optimising the chart of accounts to streamline the preparation of tax returns, and compliance reviews of the tax fixed assets register.
