- Assist in the implementation of branch administrative process and procedure and development of project management systems.
- Assist in the development of future Capital Works Programs as directed.
- Ensure projects adopt the Noosa Design Principles.
- Such other relevant duties as required from time to time which would generally fall within the scope of this position.
